



## **EIPCa Accomplishments Since its Founding in December 2010**

### **Election Integrity: Fair, Honest and Transparent**

**Every lawfully cast vote accurately counted.**

#### **Mission Statement:**

Ensure integrity of that part of our Republic through which citizens exercise our most fundamental right ~ the right to choose our representatives by fair, honest, transparent elections.

#### **Purpose Statement:**

The specific purpose of this corporation is to defend, through education, research, and advocacy (for example, providing and funding the training of election observers), the civil rights of U.S. citizens to fully participate in the election process under the Federal and State law.

#### **Since its founding in December in 2010,**

#### **EIPCa's accomplishments include:**

- 2013 - Met with the CA Secretary of State to bring attention to voter impersonation at the polls documented across the state during the 2012 election.
- 2013, 2015 - Proved ignoring voter-impersonation laws resulted in massive provisional ballots being used in 2012 and 2014 due to voters being impersonated at the polls.
- 2015 – Qualified for a hearing of the California Advisory Committee to the U.S. Commission on Civil Rights to address violations of HAVA as documented by EIPCa Data Analyst Group and EIPCa election Observation Teams.
- 2017 – Retained Judicial Watch to successfully sue the CA S.O.S. and L.A. Registrar of Voters for violation of federal voter roll maintenance laws, resulting in the cancellation of millions of ineligible registrations from 2019 to present.
- 2017 – Retained Landmark Legal Foundation to review the evidence gathered by approximately 11,000 EIP/EIPCa-trained Observers and the EIPCa Data Research Team with a view to aggressively pursuing further actions as warranted.
  - Landmark Legal filed FOUR Briefs with the Dept. of Justice and the Dept. of Homeland Security

- 2019 – EIPCa filed legal action in Fresno County in order to review the 2018 ballot envelopes and the remade ballots as part of the Inquiry and Analysis.
- 2020 – EIPCa filed legal action against Ventura County to challenge the practice of implementing policies and procedures for election management and ballot processing that supersede California laws allowing citizens to observe elections and make challenges to actions that do not comply with state and federal law.
- 2020 – EIPCa and Landmark Legal Foundation filed a Brief of Amici Curiae on behalf of EIPCa and EIPAz with the U.S. Supreme Court to assist Arizona in winning its SCOTUS case to retain their anti-ballot harvesting law.
  - Partly due to the evidence provided in our brief, SCOTUS ruled 6-3 in favor of Arizona’s right to prohibit ballot harvesting.
  - EIPCa’s Brief has the rare honor of being published in the Congressional Digest.
- 2020 - EIPCa’s Legislative Oversight team successfully martialed citizens to lobby against the element of the vote-by-mail law that could have resulted in an additional 4.5 million ballots being mailed to addresses of deceased or relocated individuals.
- 2021 – EIPCa filed legal action against the California Governor, Attorney General, Secretary of State and 13 Registrars of Voters challenging the Constitutionality of the election laws, regulations, policies and procedures used to manage elections & process ballots.
- 2022 – Our case went to the 9th Circuit Court of Appeals where they ruled EIPCa has Organizational Standing.
- 2023 and 2024--EIPCa’s Legislative Oversight team successfully opposed and testified against California’s entrance into the ERIC system.
- 2024 – EIPCa filed a Writ of Mandate regarding EIPCa’s research of the 2022 voter rolls included in the Certified election results.
  - The number of statewide November 8, 2022 votes provided in the list 43, 624 more votes than certified by the Serictory of State.
  - 21, 355 voters had two or three votes credited to their respective Registration ID numbers.
  - If these multi-votes are removed, there were still 22,210 more voters listed than the number of votes certified.
- 2025 - EIPCa worked with our attorneys at Advocates for Faith and Freedom to provide a Proposal for Federal Comprehensive Election Integrity Legislation to Congress.

The Proposal includes critical documentation of how state and federal election laws have created an election system that include multiple entry points of corruption from mismanaged voter rolls to a 60-day election season leading to the manipulation of the outcome of elections
