# And What About California?

The 2022 election in Arizona provides an important lesson for citizens of California.

What happened in Arizona's 2020 General election was a foreshadowing of what would take place in the 2022 election if citizens, candidates and legislators could not figure out how a Presidential election could be called before all the ballots from every county arrived to be counted.
