# FEDERAL HEARING ON VOTING RIGHTS JUSTICE IN CALIFORNIA HELD IN LOS ANGELES AUGUST 28, 2015: STATE ELECTED OFFICIALS TESTIFY

California is ranked 48<sup>th</sup> out of 50 states in election effectiveness according to the Pew Trust Election Performance Index (EPI) for 2012.

The California Advisory Committee to the U. S. Commission on Civil Rights probes into the reasons why California's elections are considered ineffective with respect to the rest of the United States

## LOS ANGELES, CA August 28, 2015 -

The California Advisory Committee (CA SAC, or the Committee) to the United States Commission on Civil Rights (USCCR, or Commission), a United States Federal agency\*, today held public hearing into the just Administration of Voting Rights in California. The hearing was held at the Los Angeles Central Library.

The key issues before the Committee were:

- (1) California's lack of compliance with the *Help America Vote Act* (HAVA). It is 13 years since HAVA was passed in 2002 and California has yet to comply with the law in the development of a functioning state-wide, citizen-searchable voter registration database. All other states have complied with this basic requirement;
- (2) The Pew Trust *Election Performance Index of 2012* in which California is ranked 48<sup>th</sup> out of the 50 American states in election effectiveness: and
- (3) The report by a citizens' election oversight organization, the *Election Integrity Project* (EIP) in which thousands of election and voting irregularities in California's 58 counties are documented. The emphasis at the hearing was on the county with the largest number of irregularities, Los Angeles County, and its administration of elections.

Testimonies from the general public brought concerns about election justice in other

counties: (a) those with citizen complaints of irregularities (Ventura, Kern, and Trinity, to list a few) and (b) those with improved standards of election management, in particular San Diego County.

Committee members appearing at the hearing were: Percy Duran (Chair), Nancy Eisenhart (Voting Rights sub-committee), Javier Gonzales, Susan Jester, Velma Montoya (Vice-Chair), Robin Toma, and Betty Wilson (Voting Rights sub-committee). Peter Minarik, USCCR Regional Director, Angelica Trevino, Civil Rights Analyst, and Mauro Morales, Staff Director of the USCCR were also present.

The Committee now begins preparing its report with recommendations to the Commission based on testimony delivered at the hearing and/or in electronic or paper form received by the Regional Director up to September 30<sup>th</sup>.
